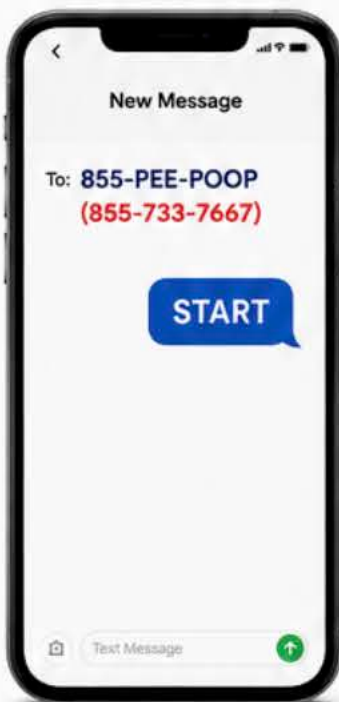


TUSHEE'S OPT-IN PROCEDURE

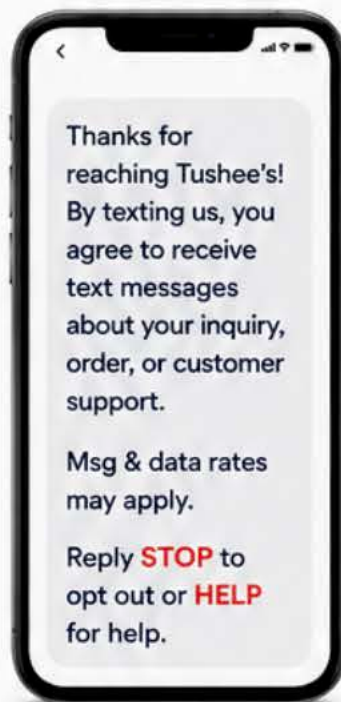
CUSTOMER TEXTS KEYWORD

CONSENT CONFIRMATION



Tushee's replies with a consent message that explains what messages will be sent and how to opt out.

CUSTOMER CONFIRMS



The customer replies **YES** to confirm consent and complete the opt-in process.

OPT-IN COMPLETE



The customer is now opted in and will receive conversational messages related to their inquiry or order.
